1	Call to Order : 7:43 pm meeting was called to order by J. Morse with 7 of 12 voting members in attendance.	Record				
2	Site Plan:					
	 V. Low goes over the project schedule included in the slideshow. Then goes over the Site Plan. Changed the basketball court and made it same size as current basketball court. Developed area next to gym as outdoor learning area. They are planning a pollinator garden and another outdoor learning area. They would like to keep the active play area away from the parking area, so they don't have to install fencing. V. Low shows a play area comparison chart of the different schools. The countryside play area is comparable to other projects. Talks about the tree survey, and there are trees that will need to come down to build the softball field, about 130" caliper to be removed. V. Low goes over the preliminary stormwater considerations. Design to comply fully with the requirements of the Massachusetts Stormwater Regulations. No increase in peak rates of stormwater discharge off site. V. Low explains a bioretention and infiltration basins areas are. She says they are depressions that a landscape features. Allows the runoff to filter through these soils. It will go through groundwater or surface to head where it naturally wants to go. A. Valcarce asks if they will look at pervious pavement at the hard surface play area. V. Low says they were talking about using porous pavers in the front plaza area. If they use this at the back asphalt area they cant paint it due to all the holes in it. 					
3	Site Plan & Building Plan Review:	Record				
	 V. Low goes over the first-floor plan. Says they relocated the platform in the cafeteria. Believes this is a better layout for the cafeteria. They moved the lunch bunch area from the inside corner to the outside corner. They are also looking at the loading dock area and locating the generator and what makes the most sense. V. Low goes over the second-floor plan. Says they are looking at different Stair A options. She shows three stair A options and explains each one. Option 1 is the most efficient and makes the most amount of sense in terms of location. Option 2 pushes the face of the stair back, Option 3 tucks the stair in the back and it gets inefficient. J. Kantar would like to see the gym moved closer to the street, and the custodial office and the electrical room more towards the back of the building. Says the heights in all of these options pose significant

- challenges. Says all the high elements will look higher due to being on the hill. Says due to the height on the south end of the building it will shade larger portion of the lower roofs that could potentially have solar on them. He says he is not enamored with any of the options.
- ➤ V. Low says they looked at the receiving and mechanical in the back, it effects how they access but will take another look at it. Clarifies the gym is two stories and the cafeteria is a story and a half, same as the media center. The classroom wing is the only one that is full three stories. The gym will cast a bit of a shadow over the cafeteria. More discussion is had about the stair and height of it in terms of the shadow.
- > T. Gloria says he agrees with the sensitivity of the massing from the east side that they need to try to keep that massing down.
- ➤ J. Morse says he's not sure they want to bring the gym closer to Dedham Street. Because they would bring a bigger mass to abutters and further separates from play areas and hardscapes.
- D. DiNisco says the gym will be the smallest of the structure. The gym will be close to 30 feet. They will look at this more for the stair.
- ➤ L. Zinner says that option 3 looks good due it being farther set back.
- A. Valcarce says they will get some views looking the other way to further investigate this.
- ➤ J. Kantar asks if they looked at a three-story stair well option then emptying out to the roof with an open stairwell.
- A. Valcarce says the open stairwell will be tough with ice and snow. Says he's wondering if they could do a sloped roof. More discussion is had about the stairwell with options to cover it, or a sloped roof.
- ➤ J. Morse says he likes the lighter material for the stair tower.
- > S. Ning Kuo says she likes option 1 better. Is worried about the classroom wing being so high.
- ➤ V. Low goes over the window and elevation studies. Shows a slide with 7 different options. Then shows the seven options with color. Then shows more options in two more slides total of 18 options. Took option 41A to look at it on a bigger scale. Shows options A1, A2, A3. The difference in options is how the windows are broken out. Then shows option B1, B2, B3.

4 Building Materials: Precedent & Considerations

Record

- ➤ V. Low goes over the exterior materials and the different brick options available. There is Modular Brick, Norman Brick, and Triple Brick. Then shows a ground face CMU block. They will share more next time on materials they can use. Then shows different material study views from different areas on the site.
- ➤ L. Zinner asks about the mural on the outdoor classroom. V. Low says they could locate it on the outside of the gym. They are also looking at incorporating murals on the inside of the school.

- P. Barrer says the look at the view from Material Study A1.2 view from Dedham St North is jarring with the windows. V. Low says they are looking at ways to use punch windows. They will develop it further.
- > S. Klickstein wants to see how the windows would look from the inside.
- A. MacKrell asks about bringing in some the lighter brick into the darker brick area. V. Low says they aired on the conservative side. They looked at different tones of brick, discusses the different colors they can use.
- > S. Ning Kuo likes the window patterns, asks for them to do a study at the main entrance at the plaza area. V. Low says they are looking at how the plaza can be further developed.
- > V. Low shows the inside of the school in the lobby, a few different views. Says the colors are not final and there will be many opportunities to review colors. Then shows the academic corridor, says they will use colors as wayfinding. V. Low shows a few views of the media center.
- V. Low then talks about sustainability and systems. For HVAC they are looking at VRF, Air Source Heat Pump w/ Fan Coil Distribution, Air Source Heat Pump w/ Chilled Beam Distribution, Ground Source Heat Pump w/ Fan Coil Distribution, and Ground Source Heat Pump w/ Chilled Beam Distribution.
- ➤ P. Barrer says he wants to consider network geothermal ground source heat pump with the neighborhood and school.
- > S. Gilman asks if the other projects are MSBA projects. P. Barrer says they are not schools.
- ➤ J. Morse says they would like to look at the legalities of it to get from point A to point B on this topic. J. Morse will look more into it.
- > V. Low says they met with Eversource and looking at what incentives are available.
- ➤ D. DiNisco talks about the Inflation Reduction Act (IRA) and she has heard that the IRA will provide 30% of the cost of the system. Then there are adders to that, because they are a non-tax paying entity they would get a check from the government. All the details haven't been fully vetted.
